#### **Query 02**

Do the training participants come from a similar contextual background? Or have you divided the participants as per the socioeconomic situation of different areas in Peshawar, KP?

70% of the training participants are Afghan Refugees while 30% are Pakistani, dwelling from different part of district Peshawar. Less than 3% of the population are Dari/Persian speaking while rest are Pashto speakers. Age of the training participants varies from 18 to 35 years. 50% of the participants are women. More than 80% are unemployed while remaining are doing jobs on daily wages. 54% training participants are illiterate, 24% are under matric while 22% are having education FA/FSC and above. 21% are married while remaining are single.

#### Query 03

Please check in your baseline report, if the project population group that is unemployed or engaged in low-paid jobs are 78% or 65%. This will help determine the sample size for the survey.

As per Rapid Needs Assessment report, the unemployment rate among the assessed Afghan Refugees is 65%.

#### Query 04

I have a query pertaining to the number of days (LOE) for the two consultants' team (female/ male) for the whole of the assignment's duration from December 2023 - May 2024. Would you please clarify the total number of working days or do you expect the consultants to propose these as per their proposals.

We do not expect consultant to propose number of days. As mentioned in ToRs, Consultant shall quote an overall lumpsum fee, inclusive of all kinds of applicable taxes (depending upon their filer/non filer status), boarding/lodging expenses (if any) or any other costs.
