- Job will require travel at multiple locations within the city of Peshawar at HOPe'87 established "shared spaces" (located in Wahid Garhi, Taj Abad, Taj Town, Nasir Bagh and Hayatabad) for Tailoring & Embroidery at and among Afghan Communities.
